Dave Rowe wrote me a paragraph or two about the poor state of the entry forms, suggesting that a number of Clubs should make appointments to see him in order to correct them. He would then arrange to be out when you called, so as to give you the sort of hassle that you have given him.

At least nine Clubs' forms were unacceptably bad, the major problems being sheets not signed and/or not dated; players not numbered; players not allocated to a division; and no Club name given on the form.

The fact that you might still get an 'A' grade at GCSE for this sort of performance doesn't make it good enough.

Dave still seems to have a large number of handbooks left. It is not clear that all Clubs collected their allocations at the Management Committee meeting. There are question marks over Bushbury; Kynoch; Mercia; Mutual Circle; and St James. If you still need handbooks please get in touch with Dave.
